### **FOREWORD**

This publication includes a part of the processed data collected by Gross fixed capital formation in 2020 - Annual report, filled by the legal entities registered in Bosnia and Herzegovina.

In preparation and conducting of survey, processing and publishing of collected data participated: Agency for Statistics of Bosnia and Herzegovina, Institute for Statistics of Federation of Bosnia and Herzegovina, Institute for Statistics of Republika Srpska and Brcko Branch Office.

The survey has been conducted in the whole territory of Bosnia and Herzegovina by using identical form which was a result of joint work of all statistical institutions.

Included are data on payments for gross fixed capital formation for main sources of financing, realized gross fixed capital formation and realized gross fixed capital formation in new fixed assets, presented by kind of construction and technical composition, by activity and place of investors, by purpose and place of investment.

Due to the fact that data from the Institute for Statistics of Republika Srpska have not been delivered in accordance with the adopted Methodological directions, data processing and publishing has been based on anonymous micro data delivered by the Institute for Statistics of Republika Srpska and complete database delivered by the Institute for Statistics of Federation of Bosnia and Herzegovina and Brcko Branch Office.

### **INTRODUCTORY REMARKS**

The value of payments for gross fixed capital formation, by main forms of investment, by activity of investor, in Bosnia and Herzegovina in 2019 was 5 381 715 thousand KM, while in 2020 the value is 5 296 165 thousand KM, which represents an decrease of 1,59 %. Observed in percentage, the greatest part was paid from own financial assets 57,61 %, then from financial credits 26,14 %, from other sources 8,22 %, from assets of budgets and funds 5,33 %, from joint assets 1,35 % and from financial leasing 1,35 %.

From 5 296 165 thousand KM that was paid for gross fixed capital formation in 2020, 5 031 071 thousand KM was paid for realized works and purchases in 2020, and 265 094 thousand KM for obligations from previous years.

The value of gross fixed capital formation in fixed assets, by activity of investor, in 2020 is 5 388 417 thousand KM, which represents an decrease of 1,04% compared to 2019. From this value, 54,65 % are construction works, 39,65 % are machinery, transport and other equipment and 0,48 % are cultivated biological resources. Intellectual property products have share of 4,98 %, and costs of transactions of land have share of 0,24 %.

The value of gross fixed capital formation in new fixed assets, by activity of investor, in 2019 was 4 902 181 thousand KM, while in 2020 the value is 4 970 607 thousand KM, which represents an increase of 1,40 %. Observed by activity of investor, the greatest shares in the total gross fixed capital formation in new fixed assets in 2020 were recorded in: Public administration and defence; compulsory social security (16,83 %), Manufacturing (13,38 %), Wholesale and retail trade; repair of motor vehicles and motorcycles (11,60 %), Transportation and storage (10,20 %), Electricity, gas, steam and air conditioning supply (9,97%), Construction (7,64 %), Human health and social work activities (7,09 %) etc.

Observed by kind of construction, from total gross fixed capital formation in new fixed assets, by activity of investor, the most investments have been invested in reconstruction, renovation, upgrade and expansion (48,88 %), new capacities (44,47%), and maintenance existing level of capacities (6,65 %).

Observed by technical composition, the greatest shares in the total gross fixed capital formation in new fixed assets, by activity of investor, were recorded in other construction works (54,18 %), machinery, transport and other equipment (37,55 %), intellectual property products (5,37 %), dwellings (2,13 %), cultivated biological resources (0,52 %) and costs of transaction of land (0,26 %).

The greatest shares in the total gross fixed capital formation in new fixed assets, by purpose of investment, in 2020 were recorded in: Construction (23,65 %), Manufacturing (13,31 %), Wholesale and retail trade; repair of motor vehicles and motorcycles (11,28 %), Electricity, gas, steam and air conditioning supply (9,95 %), Human health and social work activities (9,13 %), etc.

### **NOTES ON METHODOLOGY**

### Sources and methods of data collecting

Data on payments and realized gross fixed capital formation in legal entities are the result of the annual data collection by statistical institutions of Bosnia and Herzegovina. They are collected by a separate Annual report on gross fixed capital formation in fixed assets (INV-01 Form), by all legal entities registered in Bosnia and Herzegovina, if they are direct investors and, or acquired fixed assets record in balance sheet.

Under concept legal entities are meant:

- a) non-financial enterprises,
- b) financial enterprises,
- c) budget beneficiaries,
- d) non-profit organisations.

INV-01 Form is adapted to the international statistical standards and methodologies, that is, to the European System of Account ESA 2010, and System of National Accounts SNA 2008.

### **Coverage and comparability**

The main aim of Annual report on gross fixed capital formation in fixed assets (INV-01 Form) is collecting data in order to enable, within the system of national accounts, calculation of the gross domestic product by a consumption method, establishment of the share of gross fixed capital formation in the GDP, calculation of capital account, etc.

Considering that gross fixed capital formation, according to the European system of accounts, includes gross fixed capital formation in fixed assets, changes in inventories and net acquisitions of valuables, we notice that with this survey only data on gross fixed capital formation in fixed assets have been collected.

Gross investment abroad, except on territory that is used under contract (embassies, military base etc), and investment in local kind of activity unit abroad are not included either.

The survey has been conducted on the full scope of legal entities. Distribution of forms and collecting data have been done by Institute for Statistics of Federation of Bosnia and Herzegovina, Institute for Statistics of Republika Srpska and Branch office Brčko, in line with registers of legal entities those are led in their offices.

The classification of data collected through this survey has been done using two principles:

- by the main activity and location of investors so called organisational principle,
- by the purpose of investment so called kind of activity and territory principle.

Data classified in line with organisational principle show which legal entities (from which activities) are investors. Data classified in line with kind of activity and territory principle show in which activity and territory investment has been done.

Data processing has been done according to the European Statistical classification of economic activities NACE Rev.2 on the division level.

Data are published on the section level.

Data processing has been done at the entities level, Brčko District level and country as a whole. All data are given in current prices.

### **Definitions**

**Gross fixed capital formation in fixed assets** include purchase of enterprises and other organisations (legal entities) aimed at getting new fixed assets, increasing the value or replacing already existing fixed assets (residential buildings, other buildings and constructions, permanent equipment and installations, afforestation and planting of long-standing plantations, research and development, mining and mineral research, software and database, etc.).

Provided capital formation assets can be purchased in the country and abroad; obtained by financial lease or by barter, as a capital transfer in kind or self produced and kept for own needs.

Included are all kinds of formation in new capacities, in enlargement, reconstruction and modernization of existing and substitution of obsolete, worn-out or damaged capacities.

It does not include investment in intermediate consumption, regular and current maintenance, military weapons, obtaining of fixed assets by operative lease, purchase of fixed assets for final consumption of households, holding gains and losses in fixed assets arose as a result of disasters.

**Payment for gross fixed capital formation** are monetary investments in the year in which the payments were actually made, irrespective of the time when construction or purchase have been done.

**Gross fixed capital formation** represents the value of physically materialized construction, production or purchase fixed assets throughout a reported year, irrespective of whether they were finished or when the payment was executed.

**Realized gross fixed capital formation in new fixes assets** are related to the part of fixed assets that has been purchased directly from the contractor or producer of the equipment or self-produced, that is related to gross fixed capital formation assets still out of buying and selling transactions among users.

They include used assets purchased abroad since it directly influences on nation's affluence.

It is not included the purchase value of land than only the costs of property transfer.

**Gross fixed capital formation in new fixed assets** is investing in building up of new independent organisations, sections, roads that did not exist, or they had different purpose. As new capacities are considered: whole project as economic unit; a part of project that after building up exist as economic and technical unit, continuation of building up or equipping capital projects stopped in the past; investing in planting of long-standing plantations and breeding stock; new roads etc.

**Gross fixed capital formation for enlargement, reconstruction and renovation** are investments in already existing capacities, in order to enlarge the scope of production or services provision, change in technology; enlargement or renovation of the existing constructions, purchase of new fixed assets in the existing organizational unit.

**Gross fixed capital formation for keeping of existing equipment** are investments in order to change obsolete or worn-out fixed assets, intensify and rationalize production, without expending existing capacities or making more considerable change in the current production technology.

**Gross capital formation for construction works** includes the value of construction and equipment built-in into constructions (electro installations, central heating installations, lifts etc.) and related projects.

**Gross fixed capital formation for equipment** includes all expenses for fitting, transportation, custom duties, insurance costs and other costs for property transfer.

**Gross fixed capital formation for other assets** covers investments in breeding stock, afforestation and long-standing plantations, research and development, mining and mineral research, software and database purchased or self-developed, investment in literary and artistic originals making studies and elaborations etc.




