PRODUCER PRICE INDEX IN BOSNIA AND HERZEGOVINA IN DECEMBER 2021

Proizvođačke cijene industrijskih proizvoda (ukupno)

U prosincu 2021. godine u poređenju sa prethodnim mjesecom proizvođačke cijene industrijskih proizvoda za ukupnu industriju su zabilježile rast razine cijena za 1,1%, dok u odnosu na isti mjesec prethodne godine zabilježile rast za 10,3%.

Proizvođačke cijene industrijskih proizvoda na domaćem tržištu

U prosincu 2021. godine u poređenju sa prethodnim mjesecom proizvođačke cijene industrijskih proizvoda na domaćem tržištu su zabilježile rast nivoa cijena za 1,0%, dok su u odnosu na isti mjesec prethodne godine zabilježile rast za 8,5%.

Proizvođačke cijene industrijskih proizvoda na nedomaćem tržištu

U prosincu 2021. godine u poređenju sa prethodnim mjesecom proizvođačke cijene industrijskih proizvoda na nedomaćem tržištu su zabilježile rast za 1,4%, dok su u odnosu na isti mjesec prethodne godine zabilježile rast razine cijena za 13,3%.

Proizvođačke cijene industrijskih proizvoda (ukupno)

U prosincu 2021. godine u poređenju sa prethodnim mjesecom proizvođačke cijene industrijskih proizvoda su zabilježile rast razine u Energiji za 0,3%, Intermedijarnim proizvodima za 1,7%, Kapitalnim proizvodima za 2,5% te Netrajnim proizvodima za 0,9%, dok je pad zabilježen u Trajnim proizvodima za 0,2%.

Industrial producer prices on total market

In December 2021 as compared to previous month, Producer prices of industrial products for total industry recorded a price level increase by 1,1%, whilst compared to the same month of the previous year they recorded an increase by 10,3%.

Industrial producer prices on the domestic market

In December 2021 as compared to a previous month, the producer prices of industrial products at domestic market recorded an increase of price levels by 1,0%, while compared to the previous month of the same year they recorded an increase by 8,5%.

Industrial producer prices on the nondomestic market

In December 2021 as compared to a previous month, the producer prices of industrial products recorded an increase by 1,4%, whilst as compared to the same month of previous year they recorded an increase by 13,3%.

Producer prices of industrial products (total)

In December 2021 as compared to previous month the producer prices of industrial products increased in Energy by 0,3%, Intermediate products by 1,7%, Capital products by 2,5% and Consumer non-durables by 0,9%, whilst the decrease was recorded in Consumer durables by 0,2%.

Proizvođačke cijene industrijskih proizvoda na nedomaćem tržištu

U prosincu 2021.godine u poređenju sa prethodnim mjesecom proizvođačke cijene industrijskih proizvoda na nedomaćem tržištu više su u Energiji za 1,9%, Intermedijarnim proizvodima za 1,4%, Kapitalnim proizvodima za 3,3% te Netrajnim proizvodima za 0,4%, dok je pad zabilježen u Trajnim dobrima za 0,3%.

U prosincu 2021.godine u poređenju sa istim mjesecom prethodne godine proizvođačke cijene industrijskih proizvoda porasle su u Energiji za 17,7%, Intermedijarnim proizvodima za 17,7%, Kapitalnim proizvodima za 4,4%, Trajnim proizvodima za 2,6% te Netrajnim proizvodima za 4,9%.

Industrijska područja KD-a Proizvođačke cijene industrijskih proizvoda (ukupno)

U prosincu 2021. godine u poređenju sa prethodnim mjesecom proizvođačke cijene industrijskih proizvoda su porasle u Vađenju ruda i kamena za 0,8%, Prerađivačkoj industriji za 1,2% te Proizvodnji električne energije za 0,5%.

U poređenju sa istim mjesecom prethodne godine rast razine cijena je zabilježen u Vađenju ruda i kamena za 3,4%, Prerađivačkoj industriji za 12,5% te Proizvodnji električne energije za 2,0%.

In December 2021 as compared to the same month of previous year, the price increase was recorded in Energy by 7,3%, Intermediate products by 16,1%, Capital products by 4,7%, Consumer durables by 3,7% and Consumer non-durables by 4,5%.

Industrial producer prices on the domestic market

In December 2021 as compared to the previous month the price increase on domestic market was recorded in Energy by 0,1%, Intermediate products by 2,1%, Capital products by 0,4% and Consumer non-durables by 1,1%.

In December 2021 as compared to the same month of the previous year, the producer prices increased in Energy by 6,4%, Intermediate products by 14,1%, Capital products by 6,2%, Consumer durables by 6,6% and Consumer non-durables by 4,7%.

Industrial producer prices on the nondomestic market

In December 2021 as compared to previous month the price increase on nondomestic market was recorded in Energy by 1,9%, Intermediate products by 1,4%, Capital products by 3,3% Consumer non-durables by 0,4%, whilst the decrease was recorded in Consumer durables by 0,3%.

In December 2021 as compared to the same month of the previous year, the prices increased in Energy by 17,7%, Intermediate products by 17,7%, Capital products by 4,4%, Consumer durables by 2,6% and Consumer non-durables by 4,9%.

KD Industrial sections and divisions Producer prices of industrial products (total)

In December 2021 as compared to previous month the producer prices increased in Mining and quarrying by 0,8%, Manufacturing by 1,2% and Electricity by 0,5%.

In December 2021 as compared to previous month the prices increased in Mining and quarrying by 3,4%, Manufacturing by 12,5% and Electricity by 2,0%.

U poređenju sa istim mjesecom prethodne godine rast razine cijena je zabilježen u Vađenju ruda i kamena za 20,2%, Prerađivačkoj industriji za 13,2% te u Proizvodnji električne energije za 27,9%.

Producer prices of industrial products on domestic market

In December 2021 as compared to previous month the producer prices increased in Mining and quarrying by 0,9%, Manufacturing by 1,0% and Electricity by 0,4%.

In December 2021 as compared to the same month of the previous year, the prices increased in Mining and quarrying by 0,2%, Manufacturing by 12,0% and Electricity by 1,9%.

Producer prices of industrial products on non-domestic market

In December 2021 as compared to previous month the producer prices increased in Mining and quarrying by 0,4%, Manufacturing by 1,5% and in Electricity by 34,5%.

In December 2021 as compared to previous month the prices increased in Mining and quarrying by 20,2%, Manufacturing by 13,2% and Electricity by 27,9%.

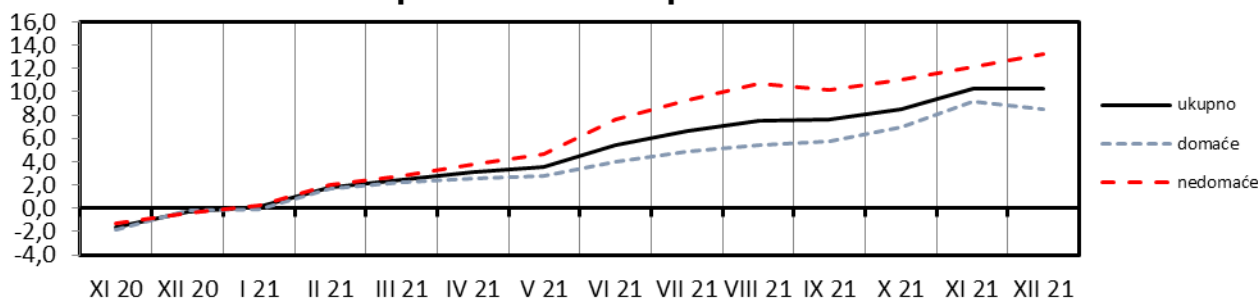

METODOLOŠKA OBJAŠNENJA

Definicija indeksa proizvođačkih cijena

Indeks cijena proizvođača industrijskih proizvoda je kratkoročni statistički pokazatelj koji predstavlja mjeru promjena cijena proizvoda koje industrijska poduzeća proizvode i prodaju na domaćem i nedomaćem tržištu.

Namjena

Prvenstvena namjena Indeksa cijena proizvođača industrijskih proizvoda je da služi kao indikator opće inflacije. Zatim služi i kao pokazatelj makroekonomskih performanci, eskalator za prilagođavanje cijena u dugoročnim ugovorima, deflator nominalnih vrijednosti outputa ili međufazne potrošnje u ostvarenom obujmu proizvodnje i deflator za nominalne vrijednosti kapitalnih troškova u nacionalnim računima, važan alat pri kreiranju i vođenju monetarnih i fiskalnih politika, kao i za donošenje informiranih ekonomskih odluka u privatnom sektoru.

Indeks cijena proizvođača industrijskih proizvoda u Bosni i Hercegovini

Indeks cijena proizvođača u Bosni i Hercegovini se izračunava na osnovu reprezentativne liste proizvoda i njihovih proizvođača koju čine oko 570 proizvodnih subjekta. Svakog mjeseca se prikuplja oko 4255 cijene izravno od samih proizvođača putem jedinstvenog obrasca koji je nastao kao rezultat suradnje sa talijanskim partnerima.

Obuhvat indeksa

Osnovni kriterij pri odabiru proizvoda i usluga koji će se mjesečno promatrati je bio kriterij proizvođača i proizvoda sa najvećom realizacijom na tržištu a prema podacima dobijenim putem godišnjeg istraživanja o industriji (IND-21). Sami proizvođači i proizvodi su odabrani od strane entitetskih Zavoda za statistiku dok su pojedinačne stavke unutar tih proizvoda odabrane od strane samih proizvođačkih poduzeća.

Snimanje cijena

Prodajna cijena proizvođača industrijskih proizvoda na domaćem tržištu je cijena po kojoj proizvođač prodaje svoje proizvode redovnim kupcima na domaćem tržištu u najvećim količinama, franco utovareno na vagon (kamion) u mjestu proizvođača. U tu cijenu ulaze regresi ukoliko ih proizvođač ostvaruje, a isključuju se trgovački rabati i popusti koje prodavac odobrava kupcu, PDV i akcize.

NOTES ON METHODOLOGY

Definition of producer price index

Producer price index is a short-term statistical indicator that represents the measurement of change of prices of industrial products produced and sold by enterprises on domestic and non-domestic market.

Purpose

This statistical indicator serves as the measure of inflation. It can also serve as the indicator of economical performances, escalator in long-term contracts, deflator for output values, intermediate consumption, and capital consumption in National Accounts and as a important tool in creating monetary and fiscal politics.

Producer price index in Bosnia and Herzegovina

PPI in Bosnia and Herzegovina is calculated based on the representative list of products and it's producers making a sample of cca.570 producers. Each month 4255 prices are collected directly from producers throug the unique questionnaire created in cooperation with Italian experts.

Coverage

The main criterion for selecting the sample of enterprises, products and services that are surveyed was the volume of production and selling on the domestic market got from the Annual survey on Industrial production (IND-21). Entities institutes of statistics have created the sample of enterprises and products and the enterprises itself have choosen the items to be priced.

Prices collection

The price that is to be collected each month on the domestic market represents a price for which producer sells his products to the regular costumers on the domestic market at maximum volume, franco loaded into a wagon (truck) at the producers location. It includes reimbursements if applicable, and it excludes commercial rabbates, disscounts, VAT and excises.

Cijena proizvođača proizvoda za strano tržište je cijena na nacionalnoj granici-FOB (free on board), što znači da prodavac plaća prijevoz robe do luke isporuke i troškove utovara, a kupac plaća prijevoz, osiguranje, troškove istovara te prijevoz od odredišne luke do krajnjeg mjesta korištenja.

Pomenuta cijena isključuje PDV i slične poreze izravno vezane za promet kao i sve takse i namete na proizvode i usluge koje poduzeća plaćaju dok se eventualno primljene subvencije na proizvode dodaju.

Sve cijene se prikupljaju mjesečno u razdoblju prikupljanja od 21.prošlog mjeseca do 20.tekućeg mjeseca. Obrazac se dostavlja proizvođačkim poduzećima koji ga popunjenog dostavljaju u centrale Entitetskih zavoda za statistiku koje vrše obradu podataka te izračunavaju indekse dostavljaju Agenciji za statistiku BiH radi njihova agregiranja za razinu Bosne i Hercegovine.

Ponderi

Ponderi koji se primjenjuju za izračun indeksa proizvođačkih cijena predstavljaju relativno učešće odabranih proizvoda u ukupnoj vrijednosti prodaje industrijskih proizvoda na domaćem tržištu. Za ovo istraživanje primjenjuju se ponderi baziraju na podacima Godišnjeg izvješća industrije (IND-a 21) iz 2015. godine dok se na razini države na relativnom učešću pojedinačnog entiteta u ukupnoj proizvodnji iz 2015. godine. Svake godine se ponderi korigiraju kretanjem cijena iz prethodne godine.

Klasifikacija

Klasifikacija industrijskih proizvoda se bazira na Nomenklaturi industrijskih proizvoda BiH 2010. utemeljene na PRODCOM listi 2010.

Agregiranje

Pri izračunu indeksa proizvođačkih cijena prvo se izračunavaju elementarni indeksi na razini proizvoda koji predstavljaju omjer cijene iz tekućeg perioda i bazne cijene (cijene iz prosinca prethodne godine). Pri tome se kao mjera srednje vrijednosti koristi prosta geometrijska sredina. Iz elementarnih indeksa se računaju agregatni indeksi klasa područja podpodručja i ukupan indeks korištenjem Laspyres-ove formule za ponderiranu aritmetičku sredinu.

The producer price for non-domestic market is a price on a national border- FOB (free on board). which means that a seller pays the transport to the port. deliverance. loading costs and a buyer pays costs of transport. assurance. unloading and transport to it's final destination.

This price exclude VAT and similar taxes directly affecting turnover and all taxes and fees on products and services that enterprises pay. The subventions received are added.

All the data should be submitted to the Entities institutes each month for the period from 21th of the previous to the 20th of current month. The Entities Institutes completes the data entry process and calculates the PPI for the level of Entity and forward the indices to the Agency for statistics of B&H that calculates the index for the state level.

Weights

Weights applied for the calculation of producer price index represent the relative share of selected products in the total value of sales of industrial products on the domestic market. Weights are based on the results of the Annual Survey on Industrial production (IND-21) for the year 2015. but for the state level the weights are based on the relative share of each Entity in the total production also from the year 2015. Each year the weights are price updated.

Classification

Classification of industrial products is based on the Nomenclature of Industrial Products in B&H 2010 based on the PRODCOM List 2010.

Aggregation

The first step in calculation of PPI is the calculation of elementary indices at the level of each products. that is the ratio between the current month price and the base price (from December of the previous year). After that the simple geometric mean is applied. The second step is the calculation of the indices of higher aggregates such as classes. divisions. subsections. sections and overall index using the Laspyres's formula for the weighted arithmetic mean.
