#### INDEKS PROIZVOĐAČKIH CIJENA INDUSTRIJE U BOSNI I HERCEGOVINI U KOLOVOZU 2022. GODINE PRODUCER PRICE INDEX IN BOSNIA AND HERZEGOVINA IN AUGUST 2022

##### **Proizvođačke cijene industrijskih proizvoda (ukupno)**

U kolovozu 2022. godine u poređenju sa prethodnim mjesecom proizvođačke cijene industrijskih proizvoda za ukupnu industriju su zabilježile pad nivoa cijena za 0,3%, dok u odnosu na isti mjesec prethodne godine zabilježile rast za 21,7%.

##### **Proizvođačke cijene industrijskih proizvoda na domaćem tržištu**

U kolovozu 2022. godine u poređenju sa prethodnim mjesecom proizvođačke cijene industrijskih proizvoda na domaćem tržištu nisu zabilježile promjenu nivoa cijena, dok su u odnosu na isti mjesec prethodne godine zabilježile rast za 22,2%.

##### **Proizvođačke cijene industrijskih proizvoda na nedomaćem tržištu**

U kolovozu 2022. godine u poređenju sa prethodnim mjesecom proizvođačke cijene industrijskih proizvoda na nedomaćem tržištu su zabilježile pad nivoa za 0,9%, dok su u odnosu na isti mjesec prethodne godine zabilježile rast nivoa cijena za 21,0%.

##### **Proizvođačke cijene industrijskih proizvoda (ukupno)**

U kolovozu 2022. godine u poređenju sa prethodnim mjesecom proizvođačke cijene industrijskih proizvoda su zabilježile rast nivoa u Energiji za 0,3%, Kapitalnim proizvodima za 0,4%, Trajnim proizvodima za 4,5% te Netrajnim proizvodima za 1,4%, dok je pad zabilježen u Intermedijarnim proizvodima za 1,8%.

*In August 2022 as compared to previous month, Producer prices of industrial products for total industry recorded a price level decrease by 0,3%, whilst compared to the same month of the previous year they recorded an increase by 21,7%.*

##### ***Industrial producer prices on the domestic market***

*In August 2022 as compared to a previous month, the producer prices of industrial products at domestic market did not record price level change, whilst compared to the previous month of the same year they recorded an increase by 22,2%.*

##### ***Industrial producer prices on the nondomestic market***

*In August 2022 as compared to a previous month, the producer prices of industrial products recorded and decrease by 0,9%, whilst as compared to the same month of previous year they recorded an increase by 21,0%.*

##### ***Producer prices of industrial products (total)***

*In August 2022 as compared to previous month the producer prices of industrial products increased in Energy by 0,3%, Capital products by 0,4%, Consumer durables by 4,5% and Consumer non-durables by 1,4%, whilst the decrease was recorded in Intermediate products by 1,8%.*

U kolovozu 2022.godine u poređenju sa istim mjesecom prethodne godine proizvođačke cijene više su u Energiji za 28,2%, Intermedijarnim proizvodima za 23,5%, Kapitalnim proizvodima za 7,8%, Trajnim potrošačkim dobrima za 19,2% te Netrajnim proizvodima za 14,1%.

U kolovozu 2022. godine u poređenju sa prethodnim mjesecom proizvođačke cijene industrijskih proizvoda su zabilježile rast nivoa u Kapitalnim proizvodima za 2,4%, Trajnim potrošačkim dobrima za 4,5% te Netrajnim potrošačkim dobrima za 1,5%, dok je pad zabilježen u Energiji za 0,1% Intermedijarnim proizvodima za 1,5%.

U kolovozu 2022.godine u poređenju sa istim mjesecom prethodne godine proizvođačke cijene više su u Energiji za 26,9%, Intermedijarnim proizvodima za 22,1%, Kapitalnim proizvodima za 14,8%, Trajnim potrošačkim dobrima za 22,6% te Netrajnim proizvodima za 15,3%.

### **Proizvođačke cijene industrijskih proizvoda na nedomaćem tržištu**

U kolovozu 2022.godine u poređenju sa prethodnim mjesecom proizvođačke cijene industrijskih proizvoda na nedomaćem tržištu više su u Energiji za 5,4%, Trajnim proizvodima za 4,6% te Netrajnim proizvodima za 1,2%, dok su niže u Intermedijarnim proizvodima za 2,1% te Netrajnim dobrima za 0,4%.

U kolovozu 2022.godine u poređenju sa istim mjesecom prethodne godine proizvođačke cijene industrijskih proizvoda porasle su u Energiji za 53,7%, Intermedijarnim proizvodima za 24,5%, Kapitalnim proizvodima za 5,3%, Trajnim proizvodima za 17,9% te Netrajnim proizvodima za 10,2%.

### **Industrijska područja KD-a. Proizvođačke cijene industrijskih proizvoda (ukupno)**

U kolovozu 2022. godine u poređenju sa prethodnim mjesecom proizvođačke cijene industrijskih proizvoda su opale u Vađenju ruda i kamena za 1,4%, Prerađivačkoj industriji za 0,1% te Proizvodnji električne energije za 1,0%.

U poređenju sa istim mjesecom prethodne godine rast nivoa cijena je zabilježen u Vađenju ruda i kamena za 24,2%, Prerađivačkoj industriji za 22,7% te Proizvodnji električne energije za 16,3%.

In August 2022 as compared to the same month of previous year, the price increase was recorded in Energy by 28,2%, Intermediate products by 23,5%, Capital products by 7,8%, Consumer durables by 19,2% and Consumer non-durables by 14,1%.

### ***Industrial producer prices on the domestic market***

*In August 2022 as compared to the previous month the price increase on domestic market was recorded in Capital products by 2,4%, Consumer durables by 4,5% and Non-durables by 1,5%, whilst the decrease was recorded in Energy by 0,1% and Intermediate products by 1,5%.*

*In August 2022 as compared to the same month of the previous year, the producer prices increased in Energy by 26,9%, Intermediate products by 22,1%, Capital products by 14,8%, Consumer durables by 22,6% and Consumer non-durables by 15,3%.*

### ***Industrial producer prices on the nondomestic market***

*In August 2022 as compared to previous month the price increase on nondomestic market was recorded in Energy by 5,4%, Consumer durables by 4,6% and Consumer non-durables by 1,2%, whilst the decrease was recorded in Intermediate products by 2,1% and Consumer non-durables by 0,4%.*

U poređenju sa istim mjesecom prethodne godine rast nivoa cijena je zabilježen u Vađenju ruda i kamena za 21,3%, Prerađivačkoj industriji za 20,8% te u Proizvodnji električne energije za 207,4%.

*In August 2022 as compared to previous month the producer prices increased in Manufacturing by 0,4%, whilst the decrease was recorded in Mining and quarrying by 0,3% and Electricity by 1,2%.*

*In August 2022 as compared to the same month of the previous year, the prices increased in Mining and quarrying by 24,0%, Manufacturing by 24,5% and Electricity by 14,8%.*

### ***Producer prices of industrial products on non-domestic market***

*In August 2022 as compared to previous month the producer prices increased in Electricity by 9,5%, whilst the decrease was recorded in Mining and quarrying by 5,7% and Manufacturing by 0,7%.*

*In August 2022 as compared to previous month the prices increased in Mining and quarrying by 21,3%, Manufacturing by 20,8% and Electricity by 207,4%.*

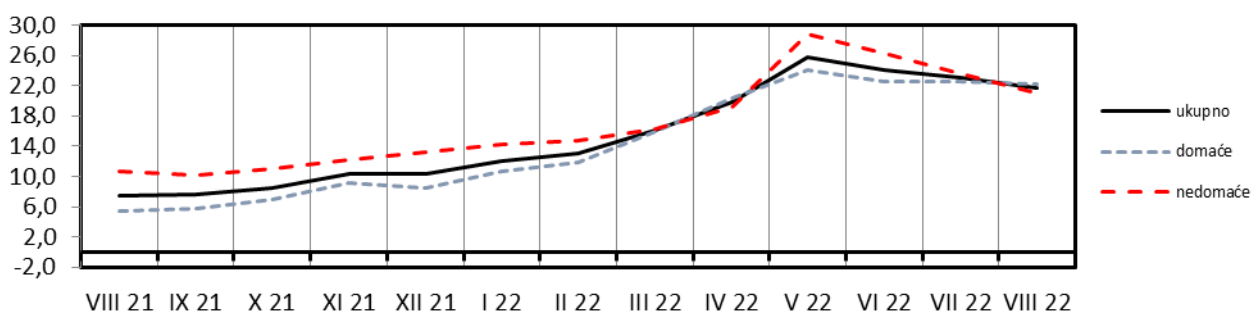

## METODOLOŠKA OBJAŠNENJA

### Definicija indeksa proizvođačkih cijena

**Indeks cijena proizvođača industrijskih proizvoda** je kratkoročni statistički indikator koji predstavlja mjeru promjena cijena proizvoda koje industrijska poduzeća proizvode i prodaju na domaćem i nedomaćem tržištu.

### Namjena

Prvenstvena namjena Indeksa cijena proizvođača industrijskih proizvoda je da služi kao indikator opće inflacije. Zatim služi i kao indikator makroekonomskih performansi, eskalator za prilagođavanje cijena u dugoročnim ugovorima, deflator nominalnih vrijednosti outputa ili međufazne potrošnje u ostvarenom obujmu proizvodnje i deflator za nominalne vrijednosti kapitalnih troškova u nacionalnim računima, važan alat pri kreiranju i vođenju monetarnih i fiskalnih politika, kao i za donošenje informiranih ekonomskih odluka u privatnom sektoru.

### Indeks cijena proizvođača industrijskih proizvoda u Bosni i Hercegovini

Indeks cijena proizvođača u Bosni i Hercegovini se izračunava na osnovu reprezentativne liste proizvoda i njihovih proizvođača koju čine oko 900 proizvodnih subjekta. Svakog mjeseca se prikuplja oko 4255 cijene direktno od samih proizvođača putem jedinstvenog obrasca koji je nastao kao rezultat suradnje sa talijanskim partnerima.

### Obuhvat indeksa

Osnovni kriterij pri odabiru proizvoda i usluga koji će se mjesečno promatrati je bio kriterij proizvođača i proizvoda sa najvećom realizacijom na tržištu a prema podacima dobijenim putem godišnjeg istraživanja o industriji (IND-21). Sami proizvođači i proizvodi su odabrani od strane entitetskih Zavoda za statistiku dok su pojedinačne stavke unutar tih proizvoda odabrane od strane samih proizvođačkih poduzeća.

### Snimanje cijena

Prodajna cijena proizvođača industrijskih proizvoda na domaćem tržištu je cijena po kojoj proizvođač prodaje svoje proizvode redovnim kupcima na domaćem tržištu u najvećim količinama, franko utovareno na vagon (kamion) u mjestu proizvođača. U tu cijenu ulaze povrati ukoliko ih proizvođač ostvaruje, a isključuju se trgovački rabati i popusti koje prodavac odobrava kupcu, PDV i akcize.

## NOTES ON METHODOLOGY

### Definition of producer price index

*Producer price index is a short-term statistical indicator that represents the measurement of change of prices of industrial products produced and sold by enterprises on domestic and non-domestic market.*

### Purpose

*This statistical indicator serves as the measure of inflation. It can also serve as the indicator of economical performances, escalator in long-term contracts, deflator for output values, intermediate consumption, and capital consumption in National Accounts and as an important tool in creating monetary and fiscal politics.*

### Producer price index in Bosnia and Herzegovina

*PPI in Bosnia and Herzegovina is calculated based on the representative list of products and its producers making a sample of cca.900 producers. Each month 4255 prices are collected directly from producers through the unique questionnaire created in cooperation with Italian experts.*

### Coverage

*The main criterion for selecting the sample of enterprises, products and services that are surveyed was the volume of production and selling on the domestic market got from the Annual survey on Industrial production (IND-21). Entities institutes of statistics have created the sample of enterprises and products and the enterprises itself have chosen the items to be priced.*

### Prices collection

*The price that is to be collected each month on the domestic market represents a price for which producer sells his products to the regular costumers on the domestic market at maximum volume, franco loaded into a wagon (truck) at the producers location. It includes reimbursements if applicable, and it excludes commercial rababates, disscounts, VAT and excises.*



Cijena proizvođača proizvoda za nedomaće tržište je cijena na nacionalnoj granici-FOB (free on board), što znači da prodavac plaća prijevoz robe do luke isporuke i troškove utovara, a kupac plaća prijevoz, osiguranje, troškove istovara te prijevoz od odredišne luke do krajnjeg mjesta korištenja.

Pomenuta cijena isključuje PDV i slične poreze izravno vezane za promet kao i sve takse i namete na proizvode i usluge koje poduzeća plaćaju dok se eventualno primljene subvencije na proizvode dodaju.

Sve cijene se prikupljaju mjesečno u razdoblju prikupljanja od 21.prošlog mjeseca do 20.tekućeg mjeseca. Obrazac se dostavlja proizvođačkim poduzećima koji ga popunjenog dostavljaju u centrale Entitetskih zavoda za statistiku koje vrše obradu podataka te izračunane indekse dostavljaju Agenciji za statistiku BiH radi njihova agregiranja za razinu Bosne i Hercegovine.

### **Ponderi**

Ponderi koji se primjenjuju za izračun indeksa proizvođačkih cijena predstavljaju relativno učešće odabranih proizvoda u ukupnoj vrijednosti prodaje industrijskih proizvoda na domaćem tržištu. Za ovo istraživanje primjenjuju se ponderi bazirani na podacima Godišnjeg izvješća industrije (IND-a 21) iz 2015. godine dok se na razini države na relativnom učešću pojedinačnog entiteta u ukupnoj prodaji iz 2015. godine. Svake godine se ponderi korigiraju kretanjem cijena iz prethodne godine.

### **Klasifikacija**

Klasifikacija industrijskih proizvoda se bazira na Nomenklaturi industrijskih proizvoda BiH 2010. utemeljene na PRODCOM listi 2010.

### **Agregiranje**

Pri izračunu indeksa proizvođačkih cijena prvo se izračunavaju elementarni indeksi na razini proizvoda koji predstavljaju omjer cijene iz tekućeg perioda i bazne cijene (cijene iz prosinca prethodne godine). Pri tome se kao mjera srednje vrijednosti koristi prosta geometrijska sredina. Iz elementarnih indeksa se računaju agregatni indeksi klasa područja podpodručja i ukupan indeks korištenjem Laspayres-ove formule za ponderiranu aritmetičku sredinu.

*The producer price for non-domestic market is a price on a national border- FOB (free on board). which means that a seller pays the transport to the port. deliverance. loading costs and a buyer pays costs of transport. assurance. unloading and trasport to it's final destination.*

*This price exclude VAT and similar taxes directly affecting turnover and all taxes and fees on products and services that enterprises pay. The subventions received are added.*

*All the data should be submitted to the Entities institutes each month for the period from 21<sup>th</sup> of the previous to the 20<sup>th</sup> of current month. The Entities Institutes completes the data entry process and calculates the PPI for the level of Entity and forward the indices to the Agency for statistics of B&H that calculates the index for the state level.*

### **Weights**

*Weights applied for the calculation of producer price index represent the relative share of selected products in the total value of sales of industrial products on the domestic market. Weights are based on the results of the Annual Survey on Industrial production (IND-21) for the year 2015. but for the state level the weights are based on the relative share of each Entity in the total production also from the year 2015. Each year the weights are price updated.*

### **Classification**

*Classification of industrial products is based on the Nomenclature of Industrial Products in B&H 2010 based on the PRODCOM List 2010.*

### **Aggregation**

*The first step in calculation of PPI is the calculation of elementary indices at the level of each products. that is the ratio between the current month price and the base price (from December of the previous year). After that the simple geometric mean is applied. The second step is the calculation of the indices of higher aggregates such as classes. divisions. subsections. sections and overall index using the Laspayres's formula for the weighted arithmetic mean.*
