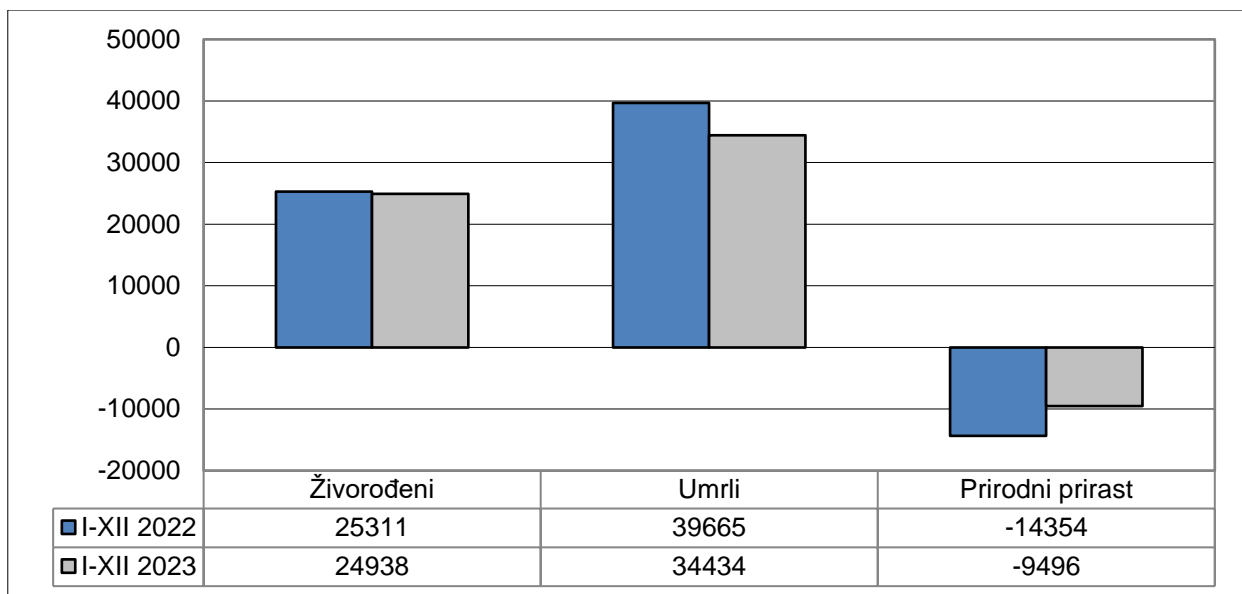
U Bosni i Hercegovini tijekom 2023. godine registrirano je 24 938 živorođene djece što u odnosu na 2022. godinu pokazuje pad broja živorođenih za 1,47%, a umrlo je 34 434 osoba, što u odnosu na 2022. godine pokazuje pad broja umrlih za 13,19%.

In Bosnia and Herzegovina in 2023, 24 938 live births were recorded, that in comparison to the 2022, indicates 1.47% decrease in number of live births; 34 434 persons died, that in comparison to the 2022 indicates 13.19% decrease in the number of deaths.

Tijekom 2023. godine u Bosni i Hercegovini sklopljen je 16 451 brak, što u odnosu na 2022. godinu pokazuje smanjenje za 2,01%. Tokom 2023. godine razvedeno je 2 259 brakova, što predstavlja povećanje od 13,01% u odnosu na 2022. godinu.

There were 16 451 marriages in Bosnia and Herzegovina during the 2023, that presents decrease of 2.01%, compared to the 2022. During the 2023 number of divorces was 2 259, that in comparison to the 2022 indicates increase of 13.01% in number of divorces.

METODOLOŠKA OBJAŠNENJA

Izvor podataka

Izveštajne jedinice prikupljanja statističkih podataka o rođenim, umrlim osobama i zaključenim brakovima su matični uredi u Bosni i Hercegovini.

Jedinice izvješća prikupljanja statističkih podataka o razvedenim brakovima su sudovi nadležni za razvode brakova u Bosni i Hercegovini.

Jedinice promatranja

Jedinice promatranja su registrirani slučajevi rođenih i umrlih osoba i registrirani slučajevi sklopljenih i razvedenih brakova u Bosni i Hercegovini.

METODOLOGICAL EXPLANATIONS

Source of data

Reporting units for the collection of statistical data on births, deaths and marriages are registration offices in Bosnia and Herzegovina.

Reporting units for the collection of statistical data on divorces are courts of competent jurisdiction in Bosnia and Herzegovina.

Observation units

The units of observation are registered cases of births and deaths and registered cases of marriages and divorces in Bosnia and Herzegovina.

Obuhvat i pokrivenost

Obuhvat je potpun. Istraživanjem su obuhvaćene sve rođene i umrle osobe, te svi sklopljeni brakovi registrirani u matičnim knjigama i svi razvedeni brakovi čiji je brak pravosnažno razveden.

Definicije i objašnjenja

Živorodenim djetetom se smatra svako dijete koje prilikom rođenja diše i pokazuje druge znakove života kao što su kucanje srca, pulsiranje pupčane vrpce i nesumnjivo kretanje voljnih mišića. Ako dijete ubrzo nakon poroda umre, najprije se registrira kao živorodeno, a zatim kao umrlo dojenče.

Umrli je svaka živorodena osoba kod koje je nastupio trajni prestanak svih vitalnih funkcija koje započinju rođenjem bez mogućnosti ponovnog oživljavanja. Ovdje nisu uključeni mrtvorodeni.

Umrlom dojenčadi smatraju se djeca koja su umrla prije navršene prve godine života.

Prirodni prirast je razlika između broja živorodene djece i broja umrlih osoba.

Vitalni indeks predstavlja odnos broja živorodenih i umrlih osoba (broj živorodenih na 100 umrlih).

Brak je zakonom uređena zajednica života žene i muškarca.

Brak se smatra razvedenim kada sudska presuda o razvodu braka postane pravosnažna.

Scope and coverage

Coverage is complete. The research covered all births and deaths and all marriages registered in the registry books and all divorced marriages whose marriage was legally divorced.

Definitions and explanations

***Live birth** is the complete expulsion or extraction from its mother of product of conception, which, after such separation, breaths or shows any other evidence of life such as beating of the heart, pulsation of the umbilical cord, or definite movements of voluntary muscles. If a product of such a birth dies, it is first registered as live-born and then as died.*

***A dead person** is every live-born person in which there is a permanent disappearance of all evidence of life at any time after live birth has taken place, without capability of resuscitation. Stillbirths are not included here.*

***Dead infants** are considered children who died under one year of age.*

***Natural increase** represents the difference between number of live births and number of deaths.*

***Vital index** represents the ratio between the number of live births and deaths (number of live births per 100 deaths).*

***Marriage** is a regulated community of life between a woman and a man.*

***A marriage is considered divorced** when the court decision on the divorce becomes final.*
