#### PRVI PUT REGISTROVANA CESTOVNA MOTORNA VOZILA ZA 2013. GODINU

*First time registered road motor vehicles for 2013 year*

U 2013. godini prvi put je registrovano 74.568 cestovnih motornih vozila, što je za 22,4% više u odnosu na prethodnu godinu.

Od ukupnog broja prvi put registrovanih cestovnih motornih vozila u 2013. godini, 83% odnosi se na putnička vozila, 7% na teretna vozila, a 10% na sve ostale kategorije vozila.

Posmatrano po tipu pogonske energije, 83% putničkih motornih vozila koristi dizel, a 17% benzin.

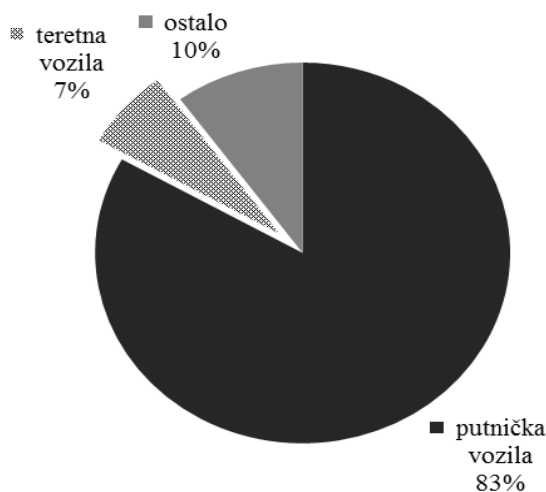
*In 2013. total number of first time registered road motor vehicles was 74.568, which is 22,4% more compared to the previous year.*

*In total number of first time registered road motor vehicles in 2013. passenger cars had share 83%, cargo vehicles 7%, and all other categories of vehicles 10%.*

*According by type of power generation, 83% of passenger vehicles use diesel, and 17% petrol as a fuel.*

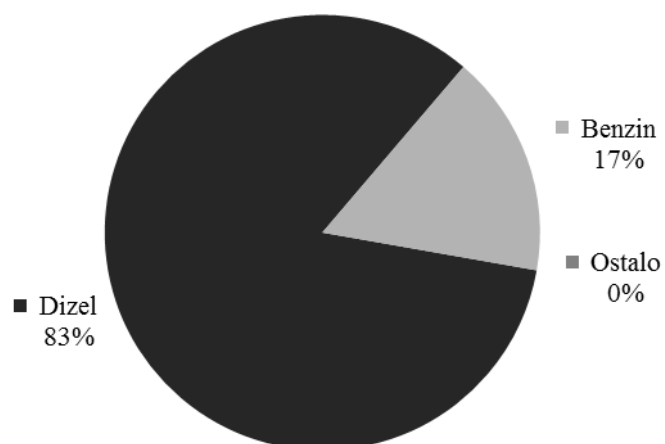

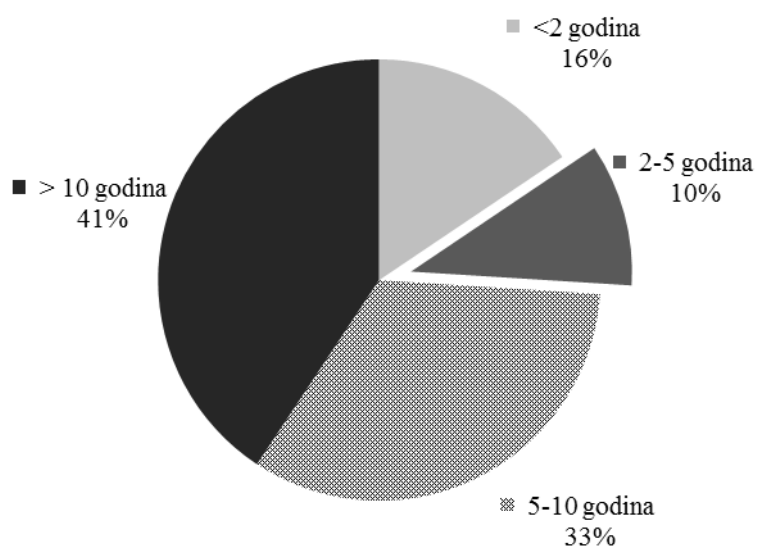

## **METODOLOŠKA OBJAŠNJENJA**

### **Izvori i metode prikupljanja podataka**

Agencija za statistiku Bosne i Hercegovine preuzela je bazu o registrovanim cestovnim motornim vozilima za 2013. godinu od Agencije za identifikacione dokumente, evidenciju i razmjenu podataka Bosne i Hercegovine (IDDEEA).

### **DEFINICIJE**

#### **Datum prve registracije**

Datum prve registracije motornog vozila je datum prve registracije novog vozila kada je upisan u jedinstvenu bazu registrovanih vozila, bez obzira na zemlju registrovanja.

#### **Prvi put registrovana vozila**

Prvi put registrovana vozila uključuju prvi put registrovana vozila u referentnom periodu (datum prve registracije) kao i ponovnu registraciju ranije registrovanih vozila, koja su određeni period bila u stanju mirovanja. U ovu kategoriju uključuju se i uvezena polovna vozila.

#### **Cestovno motorno vozilo**

Cestovno vozilo sa motorom koji čini njegovo jedino pogonsko sredstvo, koje obično služi za prevoz putnika ili robe, odnosno za vuču cestom vozila koja se koriste za prevoz putnika ili robe.

#### **Cestovno vozilo za prevoz putnika**

Cestovno vozilo koje je isključivo ili uglavnom projektovano za prevoz jedne ili više osoba.

#### **Moped**

Cestovno vozilo na dva, tri ili četiri točka sa motorom zapremine od najviše 50 cm<sup>3</sup> i čija je brzina fabrički ograničena u skladu sa važećim nacionalnim propisima.

#### **Motocikl**

Cestovno motorno vozilo na dva, tri ili četiri točka čija masa bez tereta ne prelazi 400 kg. Obuhvataju se sva ostala vozila zapremine motora od 50 cm<sup>3</sup> ili više, kao i vozila zapremine motora ispod 50 cm<sup>3</sup>, ali koja ne pripadaju kategoriji mopeda.

#### **Putnički automobil**

Cestovno motorno vozilo osim mopeda ili motocikla, namijenjeno prevozu putnika, sa najviše devet sjedišta za odrasle osobe (uključujući i mjesto vozača).

#### **Autobus ili mini-bus**

Putničko cestovno motorno vozilo projektovano da primi više od devet osoba (uključujući i vozača).

#### **Autobus, gradski**

Putničko cestovno motorno vozilo projektovano da primi više od dvadesetčetiri osobe (uključujući i vozača), namijenjeno kako za prevoz putnika koji sjede tako i za putnike koji stoje.

#### **Autobus, međugradski**

Putničko cestovno motorno vozilo projektovano za dvadesetčetiri sjedišta i više (uključujući i vozača) i konstruisano isključivo za prevoz putnika koji sjede.

#### **Mini-bus**

Putničko cestovno motorno vozilo projektovano za prevoz 10-23 osoba koje sjede ili stoje (uključujući i vozača).

## **NOTES OF METHODOLOGY**

### **Source and methods of data collection**

Agency for statistics of Bosnia and Hercegovina receives database about registered road motor vehicles in 2013. year from the Agency for Identification Documents Registers and data Exchange of Bosnia and Hercegovina (IDDEEA).

### **DEFINITIONS**

#### **Date of first registration of motor vehicle**

The date of first registration of a motor vehicle is the first-time registration of the vehicle as new in a motor vehicle register, irrespective of the nationality of the register.

#### **First time registered motor vehicles**

First time registered motor vehicles include first time registrations of vehicles (date of first registration) and registrations with a new licence of vehicles that have been previously registered and thereafter retired. Registrations of imported second-hand vehicles are included in these figures

#### **Road motor vehicle**

A road vehicle fitted with an engine whence it derives its sole means of propulsion, which is normally used for carrying persons or goods or for drawing, on the road, vehicles used for the carriage of persons or goods.

#### **Passenger road vehicle**

A road vehicle designed, exclusively or primarily, to carry one or more persons.

#### **Moped**

Two, three or four-wheeled road motor vehicle which is fitted with an engine having a cylinder capacity of less than 50cc (3.05 cu.in) and a maximum authorized design speed in accordance with national regulations.

#### **Motorcycle**

Two-, three- or four-wheeled road motor vehicle not exceeding 400 kg (900 lb) of unladen weight. All such vehicles with a cylinder capacity of 50 cc or over are included, as are those under 50 cc which do not meet the definition of moped.

#### **Passenger car**

Road motor vehicle, other than a moped or a motor cycle, intended for the carriage of passengers and designed to seat no more than nine persons (including the driver).

#### **Motor-coach, mini-coach, bus or mini-bus**

Passenger road motor vehicle designed to seat more than nine persons (including the driver).

#### **Bus**

Passenger road motor vehicle designed to carry more than 24 persons (including the driver), and with provision to carry seated as well as standing passengers.

#### **Motor coach**

Passenger road motor vehicle designed to seat 24 or more persons (including the driver) and constructed exclusively for the carriage of seated passengers

#### **Mini-bus / mini-coach**

Passenger road motor vehicle designed to carry 10- 23 seated or standing persons (including the driver).

**Trolejbus**

Cestovno vozilo za prevoz putnika sa više od devet sjedišta za odrasle (uključujući i mjesto vozača) povezano sa električnim provodnikom i koje se ne kreće po šinama.

**Cestovno motorno vozilo za prevoz robe**

Cestovno motorno vozilo, samostalno (kamion) ili kombinacija više cestovnih vozila (kamion sa prikolicom ili prikolicama, ili cestovni tegljač sa poluprikolicom i sa/bez prikolice) projektovane za prevoz robe.

**Kamion**

Robustno cestovno motorno vozilo projektovano isključivo ili uglavnom za prevoz robe.

**Cestovni tegljač**

Cestovno motorno vozilo koje je isključivo ili uglavnom namjenjeno za vuču drugih cestovnih vozila bez motora (uglavnom poluprikolice).

Ne obuhvataju se poljoprivredni traktori.

**Poljoprivredni traktor**

Motorno vozilo isključivo ili uglavnom projektovano u poljoprivredne svrhe, bez obzira da li mu je dozvoljeno ili nije kretanje po cestama otvorenim za javni saobraćaj.

**Prikolica**

Cestovno vozilo za prevoz robe koje je projektovano da bude vučeno drugim cestovnim motornim vozilom.

**Poljoprivredna prikolica**

Prikolica isključivo (ili uglavnom) projektovana u poljoprivredne svrhe i da bude vučena poljoprivrednim traktorom, bez obzira da li joj je dozvoljeno kretanje po cestama otvorenim za javni saobraćaj.

**Poluprikolica**

Cestovno vozilo za prevoz robe bez prednje osovine projektovano tako da se jedan dio vozila i znatan dio njegovog tovara oslanja na cestovni tegljač.

**Nosivost**

Maksimalna masa (težina) robe dozvoljena od nadležnog organa zemlje registracije vozila.

**Najveća dozvoljena masa vozila**

Maksimalna tehnički dozvoljena masa (najveća dozvoljena masa) je podatak koji se dobije sabiranjem mase vozila i dopuštene nosivosti.

**Masa vozila**

Masa vozila je masa praznog vozila sa punim rezervoarom goriva, priborom i opremom predviđenom za vozilo.

**Dopuštena nosivost**

Dopuštena nosivost je dopuštena masa do koje se vozilo smije opteretiti, prema deklaraciji proizvođača.

**Starost cestovnog vozila**

Broj godina proteklih od prve registracije cestovnog vozila, bez obzira na zemlju registrovanja.

**Pogonska energija**

Osnovna vrsta pogonske energije koju koriste motorna vozila odobrena od nadležnog organa zemlje registracije vozila.

**Alternativno gorivo**

Vrsta pogonske energije motora koje nije konvencionalno gorivo.

**Trolleybus**

*Passenger road vehicle designed to seat more than nine persons (including the driver), which is connected to electric conductors and which is not rail-borne.*

**Goods road motor vehicle**

*Any single road motor vehicle designed to carry goods (e.g. a lorry), or any coupled combination of road vehicles designed to carry goods, (i.e. lorry with trailer(s), or road tractor with semi-trailer and with or without trailer).*

**Lorry/Truck**

*Rigid road motor vehicle designed, exclusively or primarily, to carry goods.*

**Road tractor**

*Road motor vehicle designed, exclusively or primarily, to haul other road vehicles which are not power-driven (mainly semi-trailers).*

*Agricultural tractors are excluded.*

**Agricultural tractors**

*Motor vehicle designed exclusively or primarily for agricultural purposes whether or not permitted to use roads opened to public traffic.*

**Trailer**

*Goods road vehicle designed to be hauled by a road motor vehicle.*

**Agricultural Trailer**

*Trailer designed exclusively or primarily for agricultural purposes and to be hauled by an agricultural tractor, whether or not permitted to use roads opened to public traffic.*

**Semi-trailer**

*Goods road vehicle with no front axle designed in such way that part of the vehicle and a substantial part of its loaded weight rests on a road tractor.*

**Load capacity**

*Maximum weight of goods declared permissible by the competent authority of the country of registration of the vehicle.*

**Gross vehicle weight (Legally permissible maximum weight)**

*Maximum technically permissible weight (legally permissible maximum weight) is information which is the total unladen vehicle weight and load limit.*

**Vehicle weight**

*Weight of vehicle excluding its load weight with full tank of fuel, supplies and equipment provided for the vehicle.*

**Carrying capacity**

*Carrying capacity is permissible weight of the vehicle to be loaded, according to the manufacturer's label.*

**Age of road vehicle**

*Length of time after the first registration of the road vehicle, irrespective of the registering country.*

**Motor energy**

*The principal type of motor energy used by the vehicle as certified by the competent authority of the country registration.*

**Alternative fuel**

*A type of motor energy other than the conventional fuels.*
