GRANIČNI PROMET PUTNIČKIH MOTORNIM VOZILIMA I PUTNIKA II kvartal 2014. godine¹⁾

CROSS-BORDER TRAFFIC OF PASSENGER ROAD MOTOR VEHICLES AND PASSENGERS 2nd quarter 2014.¹⁾

U ulazu u Bosnu i Hercegovinu u II kvartalu 2014. godine granični promet putnika iznosio je 4.894.324 putnika. U strukturi ukupnog broja putnika koji su ušli u BiH, 37 % se odnosi na domaće putnike, a 63 % na strane putnike. U odnosu na vrstu prometa, 97,1 % graničnog prometa putnika se odnosi na cestovni granični promet.

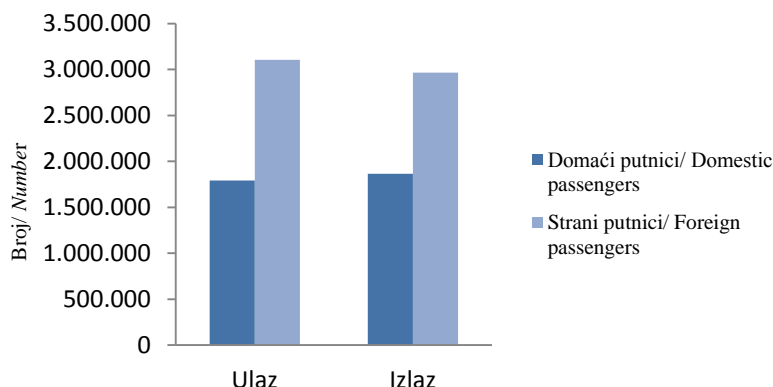
In the second quarter of 2014 year on the border of Bosnia and Herzegovina incoming traffic of passengers was 4.894.324 passengers. The structures of the total number of passengers who have entered to the BiH 37% were domestic passengers and 63% were foreign passengers. In regard to the type of traffic, 97,1% of the boundary passenger traffic refers to road border traffic.

U ulazu u Bosnu i Hercegovinu u II kvartalu 2014. godine granični promet putničkih cestovnih motornih vozila iznosio je 1.528.817 vozila. U strukturi cestovnog graničnog prometa motornih vozila, 34,5 % učestvuju domaća vozila, a 65,5 % su strana vozila.

In the first quarter of 2014 year on the border of Bosnia and Herzegovina incoming traffic of passenger road motor vehicles was 1.528.817 vehicles. The structure of the road border traffic of motor vehicles, 34,5% involved domestic vehicles, and 65,5% were foreign vehicles.
