### KLANJE STOKE I PERADI U KLAONICAMA, SEPTEMBAR 2015.

*SLAUGHTERING OF LIVESTOCK AND POULTRY IN SLAUGHTERHOUSES, SEPTEMBER 2015*

U septembru 2015. godine povećan je broj zaklanih goveda za 35,80%, ovaca za 28,22% i peradi za 4,63%, dok je broj zaklanih svinja smanjen za 16,96% u odnosu na isti period 2014. godine.


*In September 2015 the number of slaughtered cattle increased by 35,80%, of slaughtered sheep by 28,22% and of slaughtered poultry by 4,63%, while the number of slaughtered pigs decreased by 16,96% in relation with the same period of 2014.*

Neto težina zaklanih goveda je povećana za 95,03%, ovaca za 22,92% i peradi za 0,45%, dok je neto težina zaklanih svinja smanjena za 19,93% u odnosu na isti period 2014. godine.

*The net weight of slaughtered cattle increased by 95,03%, of slaughtered sheep by 22,92% and of slaughtered poultry by 0,45%, while the net weight of slaughtered pigs decreased by 19,93% in relation with the same period of 2014.*

### Metodološka objašnjenja

Podaci o klanju stoke i peradi dobiveni su agregiranjem podataka na osnovu uporedivih kvartalnih statističkih istraživanja koja provode entitetski zavodi za statistiku i podružnica Distrikt Brčko.

Poslovni subjekti i dijelovi poslovnih subjekata dostavljaju podatke na osnovu knjigovodstvene evidencije, dok se za obrtničke klaonice podaci dobivaju od nadležnih općinskih službi (veterinarsko – inspekcijskih) na osnovu raspoložive evidencije.

### Definicije

**Bruto težina** jeste težina stoke i peradi prije klanja.

**Neto težina** jeste težina očišćenog trupa, zaklane stoke i peradi bez kože, krvi, glave (osim kod prasadi i peradi), utroba, prednjih nogu do koljena i stražnjih nogu do skočnog zgloba.

**Randman** zaklane stoke i peradi predstavlja postotni odnos težine zaklane stoke i peradi (neto težine) i težine žive stoke i peradi (bruto težine), a iskazuje se u postocima s jednom decimalom.

### Notes on methodology

*The data on slaughter of livestock and poultry are result of aggregation of comparable the data from quarterly statistical surveys conducted Entity institutes for statistics and by the Bureau in Brcko District.*

*Data on legal entities and parts of legal entities are submitting data based on book-keeping, whereas for entrepreneurs avbattoirs data are given from approved municipal (veterinarian – inspection) depeartment at the basis of available evidence.*

### Definition

**Gross weight** is the weight of livestock and poultry before slaughtering.

**Net weight** is the weight of dressed carcass of slaughtered animals without skin and blood, eviscerated and beheaded (excluding piglets and poultry), and after removal of fore ends and hind legs with knuckle.

**Coefficient of utilisation** of slaughtered livestock and poultry is a percentage ratio of the weight of the slaughtered cattle and poultry (net weight) and the weight of livestock and live poultry (gross weight), and it is presented in percentage calculated to one decimal place.
